Receipt of your application to become a Gig-Capable Provider does not mean your company has achieved certification. Applicants will be evaluated for eligibility under the program's requirements, which include certification of NTCA membership and that gigabit technology is currently commercially available within 95% percent of the exchange or census block. 4. LETTER OF CONFIRMATION

A letter of confirmation must accompany this application. Letters will be accepted from qualified and credible sources capable of supporting the company's claim that it has achieved gigabit capability to 95% of at least one exchange or census block in its service territory and that gigabit technology is currently commercially available within the exchange. Reputable sources of authenticity include professional network engineering firms, telecommunications network planners and consultants, or other professional entities with direct and qualified knowledge of the applicant's network.

Letters must be signed by a current employee of the signatory firm with knowledge of the exchange or census block in consideration.

GUIDELINES AND CRITERIA

PROCESS

Applications may be submitted on an ongoing basis and will be reviewed by NTCA staff for compliance with the terms of this program. Certification will be awarded, and applications shall therefore be submitted, on an exchange-by-exchange basis.

CRITERIA

- 1. Applicants must be an NTCA member company in good standing.
- 2. Certification is obtained by submitting to NTCA documentation of the following:
 - a. Certification that gigabit technology is currently commercially available within 95% percent of one or more exchanges or census blocks, and that such service can be provided without new trenching or stringing new aerial facilities.
 - b. This statement must be confirmed by a letter from an engineering firm or other independent source involved in the company's network planning, deployment or operation.

FEES

A single, **nonrefundable** \$250 fee shall apply to applications filed simultaneously by a company for one or more exchanges or census blocks. Only check or credit card payments will be accepted. Checks should be made payable to "NTCA." To make a credit card payment, visit www.ntca.org/estore.

BENEFITS

Certified companies will be permitted to enter into a licensing agreement that enables the company to make use of the program's logo; the licensing agreement and use of the Gig-Capable logo as governed by the agreement are available only to NTCA members in good standing. Certified member companies also will be recognized in NTCA media, on the NTCA website and during association conferences and events.
