NTCA Member Testifies on Broadband Deployment at House Hearing

Greg Hale, CEO of LTC Connect (Auburn, Ky.), **testified** Wednesday before the U.S. House of Representatives Committee on Energy and Commerce Subcommittee on Communications and Technology on ways to ensure rural Americans have access to affordable and reliable broadband services.

In his **testimony**, Hale highlighted how the potential disruption of Universal Service Fund support could affect rural consumers, broadband investment and the viability of existing rural broadband networks. He also touched on ways to improve the Broadband Equity, Access, and Deployment (BEAD) program, a topic that was mentioned frequently throughout the hearing.

During his opening remarks, Rep. Richard Hudson (R-N.C.), the subcommittee's chairman, introduced the **Streamlining Program Efficiency and Expanding Deployment (SPEED)** for **BEAD Act**, a bill he said would help remove regulations and get funds to states as quickly as possible. In addition, Commerce Secretary Howard Lutnick **released a statement** saying he would revamp the program "to take a tech-neutral approach that is rigorously driven by outcomes, so states can provide internet access for the lowest cost."

Flurry of Broadband Bills Introduced in Congress

Several broadband-related bills were introduced this week in both the U.S. Senate and House of Representatives.

The **Broadband Grant Tax Treatment Act** was introduced in both chambers, led by Sens. Jerry Moran (R-Kan.) and Mark Warner (D-Va.), and Reps. Mike Kelly (R-Pa.) and Jimmy Panetta (D-Calif.). If signed into law, the bill would promote greater broadband deployment by ending taxation of certain governmental broadband deployment grant funds. NTCA endorsed the legislation and **applauded** its introduction.

In the Senate, Sens. John Thune (R-S.D.), Ben Ray Lujan (D-N.M.) and John Barrasso (R-Wyo.) introduced the **Accelerating Broadband Permits Act**. If approved, the legislation would improve federal agencies' review and processing of broadband permits by removing regulations and ensuring applications are processed within 270 days.

Additionally, the House of Representatives Committee on Energy and Commerce marked up and approved **a series of 10 bills** that focus on satellite connectivity, cybersecurity and other infrastructure-related topics. The bills now head to the full House for votes.

NTCA Urges Flexibility in Alaska Connect Fund Implementation

In **reply comments** filed with the FCC, NTCA urged flexibility in implementing the Alaska Connect Fund (ACF) to accommodate the individualized needs of carriers serving Alaska.

NTCA also emphasized the importance of allowing new ACF rules to take effect before introducing additional changes and advocated for maintaining existing tribal engagement practices.
