Dear Ms. Dortch:

On Tuesday, February 26, 2018, members and staff of NTCA-The Rural Broadband Association ("NTCA") as listed in the attachment hereto, met with Commissioner Brendan Carr and his chief of staff, Jamie Susskind, during NTCA's annual meeting in Austin, Texas. During that meeting, NTCA members advocated with respect to certain issues in the above-referenced proceedings.

Certain NTCA members first discussed their continuing concerns regarding the ability to offer affordable multichannel video programming services to consumers, including concerns specifically with respect to the unending escalation in broadcast content costs.

NTCA members then discussed both the promise of and barriers to the effective deployment of broadband infrastructure generally and 5G-enabled wireless services more specifically in rural areas. Members noted in particular the need for substantial "densification" of robust wired networks to enable 5G services, and that both economic/financial considerations *and* permitting issues continue to present significant obstacles to the widespread deployment of such services in rural America. As a related matter, NTCA encouraged policies that will make more spectrum available for use specifically in rural markets that are often neglected when licenses are awarded only in larger geographic units.

NTCA next expressed support for prompt action by the Federal Communications Commission (the "Commission") to address immediate universal service funding shortfalls that are hindering investment in the kinds of networks necessary to promote and sustain the availability and affordability of advanced services in rural areas on a basis reasonably comparable to urban areas. NTCA also urged the Commission to take prompt steps in the wake of any further rulemaking proceeding to restore longer-term predictability to the universal service programs given the long-term nature of the infrastructure investments they are intended to enable.

NTCA members also raised concerns regarding the sustainability of federal universal service support mechanisms given current deterioration in the current contributions base, and encouraged action to ensure that all those that utilize and benefit from the networks that the Commission's universal service policies support in turn contribute to the availability and affordability of those networks.

Finally, certain NTCA members discussed the need for a continuing Commission role in ensuring that networks interconnect and exchange data seamlessly with one another even in a "broadband world," even if regulatory oversight of the retail offering of mass-market broadband services may be addressed by other agencies.
